The following Ordinary Meeting of the Council is currently planned to take place at the Village Hall, How Lane, Castleton on Thursday 26th February 2026.

Visitor pressures

Work to manage visitor pressures continues on several fronts. An EMCCA (East Midlands Combined County Authority) workshop, part of the Peak Partnership Summit initiative was chaired in Bakewell (19 November) by the East Midlands Mayor Claire Ward. Cllrs Simm and Darlington participated. The main topics addressed were visitor management, transport, the rural economy, the visitor economy and housing.

The outcomes of the workshop in terms of identified Challenges and Opportunities around “**Visitor management and Behaviours**” are shown below, directly extracted from the notes.

Challenges

- High visitor volumes, especially cars, with limited contribution to local economy (e.g. free parking, minimal local spend).
- There was a lot of discussion around the statistic that ‘20 million people live within one hour’s travel of the National Park’. It was explained that the intention of the statistic is to highlight the catchment of potential visitors who can easily access the National Park from surrounding cities.
- Concerns about visitor and resident behaviours: littering, uncontrolled dogs, gates left open, inconsiderate parking. Suggestion to clamp vehicles or apply penalty points for those who park incorrectly.
- Limited awareness of the Countryside Code; signage and campaigns needed to encourage responsible behaviours.
- Social media (including TikTok) suggested to reach younger and diverse audiences.

Opportunities

- Balance between encouraging visitors and promoting responsible behaviours.
- Regional campaigns across Peak Partnership areas to promote good visitor behaviours.
- There were some discussions around a Tourism Charter for the Peak. It was explained that this has been developed by the Peak District National Park Authority in partnership with all the relevant Authorities within the National Park Management Plan. The published Tourism Charter can be found here:

- Use of signage and awareness campaigns to reinforce Countryside Code.

Summary

The Peak District faces significant pressures: high visitor numbers with limited local spend, poor behaviours, unreliable transport, low paid seasonal jobs, housing affordability issues, and restrictive planning. Rural communities feel overlooked, with weak connectivity, underfunded infrastructure, and young people leaving for better opportunities.

Opportunities lie in integrated transport systems, campaigns to promote responsible visitor behaviours, investment in skills and enterprise hubs, and diversifying the visitor economy to create better jobs and extend the season. Reforming planning, improving affordable housing, and building collaborations across the Peak Partnership can help balance tourism with community needs, protect the environment, and strengthen resilience for the future.

In the meantime, out of the Tourism Charter mentioned above, and responding to the recent challenges faced in our area supported by data showing changes to visitation patterns the PDNPA has initiated an Area Management Plan to focus on the Castleton and Mam Tor area specifically and are keeping us informed of its progress.

A meeting of Hope Valley Parish Councils will take place on 21 January in Hathersage to discuss a number of matters of mutual interest including potential joint approaches to **visitor pressures**.

Public transport and bus services January update

The key emphasis this month is the **East Midlands Combined Authority (EMCCA) Mayor's Transport Plan**. The Mayor, Clare Ward is seeking feedback on what residents think about travel in the Hope Valley and beyond and what our experiences are of travel in the East Midlands. This plan was launched in November and was highlighted at the November Peak Partnership Summit which was attended by two of our councillors along with other parish, town, borough and county councillors, plus other stakeholders. The Mayor introduced her six fights for a fairer, better connected East Midlands, but the focus on this report is transport. A series of drop-in sessions were run, one of which was in Buxton on November 22nd attended by one of our councillors and representatives from our action group, Better Buses for Castleton (BB4C).

It is worth emphasising that the **closing date is February 8th, 2026**. There are two questionnaires: Individual, and Businesses and Organisations so we need to inform and influence. The Parish Council will send a response as an organisation, but all residents are strongly encouraged to complete the Individual questionnaire. The Mayor is particularly keen to hear from rural communities and acknowledged at the Peak Summit that there were particular challenges for villages such as Castleton.

The questionnaire should take five to ten minutes to complete and there is scope to add free text with no word count. In view of the fact that the Parish Council in partnership with BB4C and Hope Valley Climate Action (HVCA) has conducted the 2024 Castleton Public Transport Survey, it is worth emphasising that our local views have been captured but must now be expressed to the Mayor. Copies of the survey were sent to the Mayor's office, but it is only now that the Transport Plan is considering local views.

Section 1 and 2 = explores ambition, goals and key policies of the Mayor's Transport Plan

Section 3 = seeks views on what the Transport Plan should prioritise and the travel challenges businesses experience across the EMCCA region.

Section 4 = gathers feedback to help improve the region's bus network.

The impact for the Hope Valley is profound as this survey is the only way of influencing the Bus Service Improvement Plan. At a recent online meeting organised by Hope Valley Climate Action (HVCA) we agreed the following pointers to help complete the survey but obviously resident's and local businesses will have their own views to express:

1. Try and be as positive as you can and tell the Mayor what you want to see in terms of public transport options. She is focusing on the bus services but will in time work with rail companies.
2. Emphasise what is important to you living in a rural community. This is crucial to make sure the majority of the funding is not directed towards cities such as Derby and Nottingham.
3. Key findings from the 2024 Castleton Public Transport Survey include - Reliable and regular bus and train services; connectivity of bus and train services and an integrated ticketing system; timetabling issues which include congestion at our bus station and on the Winnats; more bus routes to places such as Chapel-en-le Frith, Tideswell etc ; continuation of funding for the Route 62 to Buxton/Chapel;
4. Ask about bus franchising. When asked about taking control of bus services into public ownership the Mayor's response is that this will not be ruled out, and it is in her powers to implement. She has stated that whilst South Yorkshire and Manchester are pursuing this approach, she will not promise to take this approach at present but will work with bus operators to improve efficiency and develop new approaches to encourage more use of public transport. If you want to find out more then ask the Mayor for her views.

A five-year feasibility study considering an integrated transport system with the aim of delivering **Switzerland in the Peak District** has now been presented to the Mayor of East Midlands with neighbouring Mayors having been informed. HVCA are keeping the parish council fully informed.

Active Travel

The EMCCA has also secured money via Active Travel England to promote walking and cycling which is being promoted as part of the Mayor's Transport Plan outlined above. We hope a joined-up thinking approach will be followed as there have been concerns expressed over multiuser routes outlined in the DCC plan.
